Thank you for considering Pickled Jester Photography for your upcoming event! Please review the following information for pricing, picture packages, business policies and more. We look forward to working with you and if you have any questions, please let me know.

PORTRAIT & INDIVIDUAL PACKAGES

I offer two separate packages for portrait and individual packages. Both packages include a picture package, which you may elect to change if you wish. Event package pricing is based on time, and if your event exceeds the allotted time billing will be prorated for the additional time; a per hour amount for every fifteen minutes over allotted time.

You may also request a shoot lasting less than three hours at the hourly rate of \$100.00. All shoots, regardless of time, will come with Picture Package 'A'.

The times listed in both of the above packages represent studio or shooting time. Additionally, the cost of the package covers post-production (cropping, black & white, sepia, special effects, etc), online proofing¹, and touch-ups. If you have any special requests for your photographs please provide me with the details and I will do my best to accommodate your needs². Below is a brief description of my post-production services:

1. **Black & White:** I offer many forms of black and white prints for you to select, from the classic black and white print, to sepia and duotone prints. Any image you select from your proof set may be printed in black and white at your request. I will put several images on the proof set that are already black and white just as an example, but any image may be a classic black and white print.

¹ Your online proofs are secure and viewable only by the client. There is no time restriction or any additional fees for online proofing; they will be available for as long as you like.

² Please note that while I strive to provide you with the best quality product at a low cost that I may charge an additional fee depending on the nature and complexity of your request. Any additional fee's will be made clear prior to work being performed, you will not receive an unexpected bill.

2. Touch-ups: I will perform cosmetic touch ups to your photographs in order to provide you with the very finest photography for your event. Blemishes, unwanted items in the background, and sharpening are just some of the touch-ups I will provide you with.
3. Online Proofing: Within ten business days you will be able to view your proof set online to select your prints. Your proof set is secured with a username and a password so that only you will be able to view them. If you wish I will issue additional accounts so that friends and family may view them as well³. There is no additional charge for this service, and the proof set has no time limit or charge per month.

PICTURE PACKAGES AND PRICING

I offer several picture packages for you to select from, as well as other media types for you to purchase. I am flexible on amending picture packages to suit your specific needs or wants. My picture packages are limited only by the number of prints; you may choose different pictures for each image included in the package, you can select black and white, sepia, or color prints as well. If you have any questions or specific concerns please speak with me.

You may also purchase prints individually, see the 'Print Request Form' for details. You may substitute sizes in the print packages if you so desire. For further details please speak with me.

I also sell a 'Photo Disc' as an add-on to any picture package or by itself. The Photo Disc contains print-ready images, web-ready images⁵, and a reprinting agreement. The price for a Photo Disc is available for a onetime fee of \$250.00.

³ Friends and family will not be able to order prints or other products without the express, written permission of the client.

⁴ Photo albums are ordered via a separate company and will take an additional four to six weeks to deliver.

⁵ Photo Discs are ABSOLUTELY NON-REFUNDABLE.

TERMS AND POLICIES

Following are my terms of use and business policies. Please review them carefully and should you have any concerns or questions do not hesitate to ask for further details.

1. Payment: Upon your decision to use my services for your event or occasion you are to provide a down payment of 25%. This down payment secures the time for your photographic shoot. Due to my reserving the time for your event, and declining the possibility of serving other clients this down payment is non-refundable. If you need to reschedule the shooting date your down payment will apply to the new date. The remainder of your payment may be paid at any time, but must be paid in full prior to delivery of your product. You may make small payments, or pay the balance at one time; no additional fees or penalties will result. Payments by check will not be applied to your account until the check clears.

2. Pickled Jester Photography retains/owns the copyright to all photos taken during the session. Pickled Jester Photography may use these photos for advertisement, portfolio display, and other commercial uses without your knowledge, consent, or compensation, unless client wishes to purchase the 'Use Rights' from Pickled Jester Photography.

3. Client agrees to the following concerning reproduction, distribution and use of prints and electronic media:
 - a. No print/s will be reproduced without previous consent from Pickled Jester Photography. Clients who have purchased a 'Photo Disc' may reprint any and all photos for personal use without further consultation with Pickled Jester Photography.
 - b. Photography in other mediums (CD, slideshow, etc) will not reproduced, copied, replicated, or distributed in any way shape or form. Should client wish to procure additional copies of such medium client will purchase them from Pickled Jester Photography.
 - c. Client will not attempt to utilize prints or computerized media for professional or commercial use without first consulting with Pickled Jester Photography, in addition to obtaining explicit permission from Pickled Jester Photography. Should client be given permission to utilize images for commercial/professional use client agrees to abide by all terms and conditions set forth by Pickled Jester Photography.

4. Generally ten business days are required to process your photographs. This time allows for post-production, online proofing, and any printing needing done. Exceptions for the 'ten business days' are as follows:
 - a. Wedding albums: These are a specialized product, a professionally assembled book to be exact. Additional time must be allowed for the completion of this product, up to one month.
 - b. Large prints: Prints up to 12x18 are printed locally and are ready within the allotted time frame for completion. Prints in the size of 16x20 and larger must be ordered and therefore require additional time for delivery. Other printing projects (canvas prints or other specialized prints) will also require additional time. Please speak with me regarding the time requirements for specific projects.

5. Due to the nature of the product and the time required to produce and deliver the product there will be no refunds for the following portion of my services:
- a. Down payment (as detailed above).
 - b. Session cost. The session cost covers the time allocated to your event, and is non-refundable⁶. Should you be dissatisfied with the quality of your pictures a refund will be issued for the cost of the picture package only.
 - c. Shipping and handling fees will not be refunded.
 - d. Photo Discs are absolutely non-refundable.
 - e. Clients who have ordered a 'Photo Book' are not entitled to a refund for said photo book. These items are ordered and printed via a third party. If you are dissatisfied with the quality of the book or if there are obvious errors or mistakes in the book I will contact the publisher and request a new copy at no cost if at all possible.
 - f. Due to the nature of my business clients must request a refund within five days of receiving the final product, i.e., the printed photographs. Requests for a refund outside of the five day period will be refused.
